During 2014 we have worked to reduce our organization's risk through policies, training and insurance. Policies addressing confidentiality and harassment were attached to our revised Orientation Guide. We had an excellent training session with Weekly Coordinators and Lead Volunteers. The Board approved applying for Director and Officer Insurance. Early in 2015 we will implement a client data base that uses only the last four digits of social security numbers.

Welcome to our newest Board Member, Ray Scharfenberger. Ray fills the position created by Bud Voorhess's resignation. Ray has agreed to look for additional grant support for FISH.

Please use the "What Does FISH Need" handout on the shelf near the pantry door. The last time I volunteered in the pantry and used that list, a caller responded that a volunteer told her not to bring those items because we buy them. We buy them because they are the primary items distributed to clients. In the last two years we have experienced an 18 and 20 percent growth respectively in meals provided, and expenses have exceeded income. Every item donated is one we do not have to purchase.



TRANSPORTATION REPORT

Grateful thanks to Ward Wheatall, who has retired as a FISH volunteer after over 15 years as a transportation scheduler and driver.

FISH volunteers provide rides to medical appointments for folks without other means of transport. Faith in Action provides rides for their clients and the Peninsula Agency on Aging Rides

program serves people age 60 and older. Over the past two years the number of one-way rides provided by FISH has almost doubled from an average of 25.2 to 45.8 in 2013 to 50.8 in the first 9 months of 2014. The number of one-way rides provided in recent months: June -82, July -44, August -48, and September -37.



During the last 2 months, 20 different drivers have taken people to medical appointments in the area including 3 round-trips to Richmond. Ride request messages are left on the FISH Transportation telephone line and volunteer transportation schedulers check the messages and telephone to find available drivers.

Recently one of our drivers shared the good news that a regular client has healed completely after many visits for a serious wound; this was made possible by the faithful FISH drivers willing to take her. God's grace is shown in many ways!

Currently there are only 4 transportation schedulers and 24 drivers. We desperately need 2 more volunteers willing to take a week about 10 times a year to schedule rides, as well as some additional willing drivers. Otherwise, FISH will not be able to continue this basic service cited in our bylaws.

PANTRY AND CLOTHES CLOSET

At the October Board meeting, Billie Johnston reported the fire marshal was in to inspect the premises. We passed the inspection. His directives are that doors into the waiting room from outside, and doors into the clothing room **must be kept shut** throughout the day. Volunteers should check on this from time to time. On another matter, donations put on the benches and

orders kept out in the waiting room are being taken by clients; probably thinking they are free items. **All volunteers take note please**...all completed orders should be kept inside the pantry until the client is ready to leave the premises. All donations coming in, need to be placed inside the pantry, storage room, or clothing room. Do not leave them in the waiting room.

The average daily workload was 21/23. A total of 448 requests came to the pantry in August, 485 in September, a continuing increase over the last three months. The number of requests in September was second only to January, 2013 which was 528 requests.
